Sub.: Structural Audit Report of School building of Cosmopolitan Education Society at above mentioned address. Bearing CTS No.195/199.

Respected Sir,

Brief background of buildings' structure:

As per Architectural drawings (available with Cosmopolitan Education Society records) shown to me, the building was constructed during 1984 or so. There were signs of previous repairs.

As requested by you. We have inspected the structure of the said building during February' 2020 and suggested that structural repairs need to be carried out by a contractor experienced in polymer, epoxy and micro concrete repairs.

Subsequently, repairs were carried out by an experienced contractor under day-to-day supervision by society appointed supervisor, and our guidance, in the form of periodic visits, as per contractor's requirements.

Further to our observations regarding multipurpose hall which is as below.

It is placed on ground floor & covered with AC sheet roofing supported by MS frame work. There is a false ceiling at bottom level of roof truss which is rested on lightweight frame work fixed to walls. Thus there is no extra load on roof frame work and hence no need to worry in this regard as structural stability is not disturbed.

This is to state that the repairs have been carried out as per standard engineering practice, and that the said school building is structurally stable and safe to be used for the purpose intended, to best of my knowledge. (Considering the age of the building and the history of earlier repairs and maintenance).
